- 1) The financial results of the Company for the year ended March 31, 2015, which have been audited by the Company's Statutory Auditors, have been reviewed by the Audit Committee of the Board and have been approved and taken on record by the Board of
- During the year, the Company has sold an investment for a total consideration of Rs.25,600 lakh resulting in a gain of Rs.6,254 lakh which is disclosed as part of income from investments.
- 3) During the year, the Company declared an interim dividend of Re. 0.60 per equity share (previous year : Re. 0.50 per equity share) of Rs. 10 each aggregating Rs. 7,785 lakh (previous year: Rs. 6,488 lakh) and has paid Dividend Distribution Tax thereon: Rs. 1,557 lakh (previous year : Rs. 1,103 lakh).
- During the year ended March 31, 2015, the Company has reassessed depreciation rate on tangible fixed assets as per the useful life specified in the Companies Act, 2013. As a result of the change, the charge on account of the depreciation for the year ended March 31, 2015 is higher by Rs. 235 lakh compared to the charge based on useful lives estimated in earlier period.
- 5) Investments in Bonds, Debentures and other financial Instruments which, in substance, form part of the Company's financing activities have been classified under Loans and Advances- Financing Activity. In the past these were classified as part of investments. The Management believes that the current year's classification results in a better presentation of the substance of these receivables and is in alignment with regulatory filings with Reserve Bank of India.
- 6) Figures for the six months ended March 31, 2015 and March 31, 2014 represent the difference between the audited figures in respect of the full financial years and the published figures of half year ended September 30, 2014 and September 30, 2013 respectively.
- Figures relating to the previous period / year have been regrouped / reclassified/ recast where necessary to conform to the current period's classification / computation.
