**Hearing Through: Virtually and Physical (Hybrid) Mode**

1. Heard the Learned Counsel appearing for the Petitioner Companies and above Company Petition is **admitted**, returnable on **01.04.2025**.
2. The Petitioner shall publish the notice at least 10 days before the next date of hearing in two newspapers, i.e., **“Navshakti”** in Marathi language and **“Business Standard”** in English language.
3. Learned Counsel for the Petitioner Companies states that all compliances have been made to the directions given in C.A.(CAA)/191(MB)2024.
4. The Petitioner Companies shall issue notices through R.P.A.D./ Speed Post/ Email and Hand Delivery upon: - (i) Regional Director, Western Region, MCA, Mumbai; (ii) Concerned Registrar of Companies; (iii) jurisdictional Assessing Officer(s) of Income Tax Department; informing the date fixed for hearing as per Rule 8 of the Companies (Compromises,



Arrangements and Amalgamations) Rules, 2016, with a direction that they may submit their representation, if any, within 30(thirty) days from the date of receipt of such notice.

5. Petitioner Companies shall also issue notice to following authorities, if applicable; (i) Official Liquidator; (ii) GST Authorities; (iii) Securities and Exchange Board of India (SEBI); (iv) Bombay Stock Exchange (BSE); (v) National Stock Exchange (NSE); (vi) Reserved Bank of India (RBI); (vii) RERAC; (viii) CCI; informing the date fixed for hearing as per Rule 8 of the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016, with a direction that they may submit their representation, if any, within 30 (thirty) days from the date of receipt of such notice.
6. The Petitioner Companies shall file a compliance Affidavit regarding the issue of advertisement of the notice of the hearing of the Company Scheme Petition as well as the proof of service of notices to the above-mentioned concerned authorities stating the directions of this Tribunal, have been duly complied with.
7. Above authorities shall file their report, if not already filed, before the next date of hearing.
