The HQLA comprises of two components for quarter ended December 2022, cash and government securities. Both the components attract zero haircut and have highest liquidity. For quarter ended December 2022 the average HQLA of ₹ 2,185.50 cr. (as per the market value) comprises of ₹ 17.25 crs in cash and remaining ₹ 2,168.25 crs. from government securities and T-Bill.

For the quarter ended December 31, 2022, data has been presented as simple averages of daily observations over the quarter. The company is complied with the LCR requirement for the quarter ended December 2022. The average LCR of the Company for the quarter ended December 31, 2022 was 86.78%.
