The HQLA comprises of two components for quarter ended September 2023, cash and government securities. Both the components attract zero haircut and have highest liquidity. For quarter ended September 2023 the average HQLA of ₹ 2,843.56 crs. (as per the market value) comprises of ₹ 2.75 crs in cash and remaining ₹ 2,840.80 crs. from government securities and T-Bill.

For the quarter ended September 30, 2023, data has been presented as simple averages of daily observations over the quarter. The company is complied with the LCR requirement for the quarter ended September 2023. The average LCR of the Company for the quarter ended September 30, 2023 was 110%.
