SUMMARY OF PROCEEDINGS OF THE FIFTEENTH ANNUAL GENERAL MEETING OF TATA CAPITAL HOUSING FINANCE LIMITED

The Fifteenth Annual General Meeting ("AGM" / "Meeting") of the Members of Tata Capital Housing Finance Limited ("the Company") was held, at a shorter notice, on Tuesday, June 27, 2023 at 10.00 a.m. through Video Conferencing ("VC").

Mr. Rajiv Sabharwal, Chairman, chaired the Meeting.

The requisite quorum being present, the Chairman called the Meeting to order and welcomed all the Members to the AGM of the Company.

Mr. Rajiv Sabharwal, Chairman of the Board and Chairman of the Stakeholders Relationship Committee, Mr. Mehernosh B. Kapadia, Independent Director and Chairman of the Nomination and Remuneration Committee, Mr. Sujit Kumar Varma, Independent Director and Chairman of the Audit Committee, Ms. Malvika Sinha, Independent Director and Mr. Anil Kaul, Managing Director of the Company attended the AGM through VC. Mr. Ankur Verma, Non-Executive Director was unable to attend the AGM owing to pre-occupation. The Representatives of the Joint Statutory Auditors and the Head - Internal Audit of the Company also attended the AGM. The Secretarial Auditor, citing pre-occupation, was granted exemption from attending the AGM.

The relevant statutory registers and documents as prescribed under the Companies Act, 2013 / Secretarial Standards were made available for inspection. As the Statutory Auditors Report and the Secretarial Audit Report had no qualifications or adverse observations / comments, the same was not required to be read. With the consent of the Members present, the Notice of the AGM was taken as read. Thereafter, the Chairman initiated the proceedings of the Meeting and briefed the Members on the objectives and implications of the Resolutions set out in the Notice, which were proposed to be passed at the AGM. The Chairman invited queries from the Members on the businesses to be transacted at the AGM. There were no queries from the Members.
