# <u>Summary of the proceedings of the Extra- Ordinary General Meeting of</u> Tata Motors Finance Limited (Formerly Tata Motors Finance Solutions Limited)

The Extra- Ordinary General Meeting ("said EGM") of Tata Motors Finance Limited (Formerly Tata Motors Finance Solutions Limited) ("the Company") was held on Wednesday, January 24, 2024, at 4.40 p.m. (IST) through Video Conferencing ("VC"). The Company, while conducting the said EGM, adhered to the applicable provisions of the Companies Act, 2013 read with the Circulars issued by the Ministry of Corporate Affairs ("MCA") with respect to the holding of Extra- Ordinary General meeting through VC, from time to time.

The venue for the said EGM was the Registered Office of the Company i.e. 14, 4<sup>th</sup> Floor, Sir H.C. Dinshaw Building, 16, Horniman Circle, Fort, Mumbai – 400001.

Mr. Nasser Munjee, Chairman of the Board, chaired the meeting and he welcomed all the Shareholders, Directors and other participants. Since the requisite quorum was present, Mr. Nasser Munjee called the meeting to order. He then requested Mr. Vinay Lavannis, Company Secretary to commence the proceedings of the meeting.

The Directors present at the said EGM were Mr. Nasser Munjee, Mr. P. S. Jayakumar, Mrs. Vedika Bhandarkar, Mrs. Varsha Purandare, Mr. N. V. Sivakumar, Mr. P. B. Balaji, Mr. Dhiman Gupta and Mr. Samrat Gupta. The said EGM was also attended by Ms. Ridhi Gangar, Chief Financial Officer.
