

#### **Terms and Conditions**

### • For Accessing the Portal

This is a legally binding agreement between 'you', the user, and Tata Capital Limited and all its subsidiaries ("We"/ "us"/ "the Companies"), establishing the Terms and Conditions ("Terms") under which any service offered by Tata Capital Wealth via its web Portal or WhatsApp Account (hereinafter referred to as "Portal") may be used/accessed. You acknowledge that Tata Capital Financial Services Limited ("TCFSL") is registered with The Association of Mutual Funds in India as a Mutual Fund Distributor bearing ARN No.84894 and Tata Capital Wealth is a service offering by TCFSL.

- 1. The User shall, in addition to above also be governed by these Terms and Conditions when accessing the same through a designated Relationship Manager assigned to the User by Tata Capital Financial Services Limited ("the Company"). Tata Capital Financial Services Limited ("TCFSL") is registered with The Association of Mutual Funds in India as a Mutual Fund Distributor bearing ARN No.84894 and Tata Capital Wealth is a service offering by TCFSL. The Terms and Conditions shall constitute a binding contract between the Company and the User.

- **7.**You understand that mutual fund transactions executed through your investment account with the Company will be routed through NSE Mutual Fund Platform (NMF II Platform) of National Stock Exchange of India Limited (NSE).

You confirm your acceptance to register under NMF II Platform and abide by the terms & conditions, as may be prescribed by NSE in this regard from time to time.

You authorise NSE to collect the necessary data /information pertaining to your Mutual Fund Investments from all AMC's and their respective RTAs with whom you transact. The data / information authorised to be collected would inter alia include:

- •Distributor wise transaction data for past, present and future transactions carried out by you through various transaction platforms including transaction request submitted at any point of acceptance of the AMC subject to the condition that distributor is registered with NSE NMF II Platform
- •Scheme wise consolidated unit balance available in your accounts as and when required.
- **8.**As per SEBI guidelines the cut off time for accepting orders in Liquid/Overnight funds is 13:30 hrs and in all other schemes is 15:00 hrs. However, taking into consideration the internal processing time, the cut off time prescribed by NSE for accepting orders is as follows-
  - •For purchase in Liquid funds and Overnight funds: 12:40 pm
  - •For purchase in all schemes other than those mentioned above: 2:10 pm
  - •For redemption and switch in all schemes: 3:00 pm

These cut offs, allotment of NAV is subject to realization of funds in the accounts of the Asset Management Companies / Fund Houses.

You agree that you understand the terms and conditions mentioned below, in case you choose your payment mode as online / debit mandate.

You have selected payment mode as Online mode / Debit Mandate mode method for executing the purchase transaction. Please note the following for non-liquid transactions:

## **Online payment method:**

•For Purchase transactions from all banks except HDFC Bank, units will be allotted on next working day NAV (T+1) or realization of funds in AMC account, if the transaction is authorized by client before cut-off.

- •For Purchase transactions from all banks except HDFC Bank, units will be allotted on subsequent working day NAV (T+2) or realization of funds in AMC account, if the transaction is authorized by the client after the cut-off date.
- For Purchase transactions from HDFC Bank account, units will be allotted on same day NAV if received within cut-off else next working day if post cut-off.

# **Debit Mandate:**

- •For purchase transactions (irrespective of bank) units will be allotted on subsequent working day NAV (T+2) or realization of funds in AMC account, if the transaction is authorized by the client before cut-off date.
- •For purchase transactions (irrespective of bank) units will be allotted on subsequent working day NAV (T+3) or realization of funds in AMC account, if the transaction is authorized by the client after cut-off date.
- **B.**For liquid purchase transactions from all banks except HDFC Bank, units will be allotted on same day NAV if transaction is authorized before cut-off else next working day if post cut-off.
- **C.**For liquid transactions from HDFC Bank account, units will be allotted on previous day NAV if transaction is authorized before cut-off else same day NAV if post cut-off.
