Terms & Conditions

- 1. This campaign is exclusively for the employees of Tata Capital Ltd & its subsidiaries for referring employees to Tata Capital Wealth which is a service offering of Tata Capital Limited ("TCL")
- 2. Employees can give references ("Referrals") in order to qualify for an assured incentive. In case the details of the Referrals are incomplete/ incorrect/ invalid, the employee shall not be entitled for any incentives.
- 3. We have a dedicated portal/link wherein each employee can refer unlimited referrals. In order to be eligible for the incentives, referrals will be accepted through the dedicated portal/link ONLY.
