The HQLA comprises of two components for quarter ended December 2021, cash and government securities. Both the components attract zero haircut and have highest liquidity. For quarter ended December 2021 the average HQLA of ₹2,107.35cr. (as per the market value) comprises of ₹30.58cr in cash and remaining ₹2,076.77cr. from government securities and T-Bill.

For the quarter ended December.31.2021, data has been presented as simple averages of daily observations over the quarter. The company is complied with the LCR requirement for the quarter ended December 2021. The average LCR of the Company for the quarter ended December 31, 2021 was 86.16%.
